These novels embody the American Indian point of view; the non-Indian is required to assume the role of other. In his analysis Owens draws on a broad range of literary theory: myth and folklore, structuralism, modernism, poststructuralism, and, particularly, postmodernism. At the same time he argues that although recent American Indian fiction incorporates a number of significant elements often identified with postmodern writing, it contradicts the primary impulse of postmodernism. That is, instead of celebrating fragmentation, ephemerality, and chaos, these authors insist upon a cultural center that is intact and recoverable, upon immutable values and ecological truths. *Other Destinies* provides a new critical approach to novels by American Indians. It also offers a comprehensive introduction to the novels, helping teachers bring this important fiction to the classroom.
