DOWNLOAD AND SAVE ALL NECESSARY TRANSACTION RECORDS AND REPORTS FROM YOUR BUSINESS ACCOUNT. THIS IS CRUCIAL FOR TAX PURPOSES AND FINANCIAL TRACKING.
