When inspector Cadin of the Toulouse prefecture learns of the unsolved murder of the young man's father, he suspects a connection. But why would anybody want to kill two bourgeois, politically unconnected history teachers? Didier Daeninckx has located the link between the two murders in the history that France had yet to confront -- in its colonial racism and its complicity in genocide.
