KEY CONCEPTS IN BEHAVIOR ANALYSIS:

OPERANT CONDITIONING: THIS FUNDAMENTAL PRINCIPLE DESCRIBES HOW BEHAVIORS ARE LEARNED THROUGH CONSEQUENCES. REINFORCEMENT INCREASES THE LIKELIHOOD OF A BEHAVIOR BEING REPEATED, WHILE PUNISHMENT DECREASES IT. POSITIVE REINFORCEMENT INVOLVES ADDING SOMETHING DESIRABLE (E.G., GIVING PRAISE), WHILE NEGATIVE REINFORCEMENT INVOLVES REMOVING SOMETHING UNDESIRABLE (E.G., STOPPING A LOUD NOISE). PUNISHMENT WORKS SIMILARLY, BUT BY DECREASING THE LIKELIHOOD OF A BEHAVIOR THROUGH ADDING SOMETHING UNDESIRABLE (E.G., GIVING A REPRIMAND) OR REMOVING SOMETHING DESIRABLE (E.G., TAKING AWAY PRIVILEGES).

CLASSICAL CONDITIONING: ALSO KNOWN AS PAVLOVIAN CONDITIONING, THIS DESCRIBES HOW WE LEARN TO ASSOCIATE TWO STIMULI. A NEUTRAL STIMULUS BECOMES ASSOCIATED WITH A NATURALLY OCCURRING STIMULUS (UNCONDITIONED STIMULUS) THAT ELICITS A RESPONSE (UNCONDITIONED RESPONSE). THROUGH REPEATED PAIRINGS, THE NEUTRAL STIMULUS EVENTUALLY ELICITS THE SAME RESPONSE (CONDITIONED RESPONSE) EVEN WITHOUT THE UNCONDITIONED STIMULUS (E.G., PAVLOV'S DOGS SALIVATING AT THE SOUND OF A BELL).

THREE-TERM CONTINGENCY (ABC): BEHAVIOR ANALYSIS UTILIZES THE ABC MODEL TO UNDERSTAND BEHAVIOR. A STANDS FOR ANTECEDENT (THE EVENT PRECEDING THE BEHAVIOR), B STANDS FOR BEHAVIOR (THE ACTION ITSELF), AND C STANDS FOR CONSEQUENCE (THE EVENT FOLLOWING THE BEHAVIOR). UNDERSTANDING THE ABCS ALLOWS FOR EFFECTIVE INTERVENTION AND BEHAVIOR MODIFICATION.

FUNCTIONAL BEHAVIOR ASSESSMENT (FBA): THIS IS A CRUCIAL PROCESS USED TO IDENTIFY THE FUNCTION OF A BEHAVIOR. INSTEAD OF SIMPLY LABELING A BEHAVIOR AS "BAD" OR "GOOD," AN FBA AIMS TO UNDERSTAND WHY THE BEHAVIOR IS OCCURRING. THIS INVOLVES LOOKING AT THE ANTECEDENTS AND CONSEQUENCES THAT MAINTAIN THE BEHAVIOR.

to fill that need. Twenty-one case studies are provided--case studies with complete analysis, case studies with partial analysis, and case studies without analysis. The first seven cases present a complete analysis, which allows the reader to analyze and develop a comprehensive Positive Behavior Support Plan containing detailed answers and supporting data systems. The second seven case studies include the areas from the BACB Task List, and the items are most relevant for analysis, but the analysis is not complete. This enables the reader to complete the analysis themselves which will promote skill building. The final seven case studies do not contain an analysis or guideline. This allows the reader to further develop their skills by creating their own guidelines for analysis, and implementing their plan. The use of this text will improve the comprehensive analysis and coverage of the developing supports for individuals with disabilities, provide direct applicability to applied settings, and the ability to use the case studies for assignments and/or exams. The format, readability, and detailed description of instructional methodology makes this text a valued resource for instructors and behavior analysts responsible for improving the skills of people with disabilities.
