FAIR HOUSING LAWS: DISCRIMINATION IN HOUSING IS ILLEGAL. FAMILIARIZE YOURSELF WITH THE PROTECTED CLASSES UNDER THE FAIR HOUSING ACT AND UNDERSTAND HOW TO AVOID DISCRIMINATORY PRACTICES.

PROPERTY OWNERSHIP: DIFFERENT TYPES OF OWNERSHIP HAVE DISTINCT LEGAL IMPLICATIONS. UNDERSTAND THE NUANCES OF FEE SIMPLE OWNERSHIP, JOINT TENANCY, TENANCY IN COMMON, AND OTHER FORMS OF OWNERSHIP.

ANSWER: $\$300,000 \times 0.06 = \$18,000$

QUESTION: WHAT SHOULD YOU DO IF YOU DISCOVER A MATERIAL DEFECT IN A PROPERTY YOU'RE REPRESENTING?

ANSWER: YOU HAVE A LEGAL AND ETHICAL OBLIGATION TO DISCLOSE THE DEFECT TO YOUR CLIENT IMMEDIATELY.
