THIS INFORMATION HELPS IN ASSESSING THE LONGEVITY AND CREDIBILITY OF THE BUSINESS.

Q: HOW UP-TO-DATE IS THE INFORMATION IN THE UTAH DEPARTMENT OF COMMERCE'S REGISTRY? A: WHILE THE REGISTRY IS REGULARLY UPDATED, THERE MIGHT BE A SLIGHT DELAY BETWEEN A BUSINESS UPDATE AND ITS REFLECTION IN THE DATABASE.
