In this refusal of national belonging and form, the book asks for a

critical kinship that the law can never account for, and thus, Pelaez Lopez negotiates legal status for new imaginaries of care. As a whole, the manuscript asks: what does it mean that a descendant of enslaved Africans becomes an illegal alien in the same continent that subjugated their ancestors to chattel slavery? Furthermore, can an Indigenous subject of this continent be considered 'illegal' in the continent of their ancestors?

along with a neighbor that he strongly dislikes: The barbed wire around us forces me / to catch his breath that smells like goose. Chang focuses her attention to occurrences in the world that many poets find too violent or disturbing to write about, thereby making her own distinctive aesthetic from that which is, like *Salvinia molesta*, both creepy and beautiful.
