After he became president in 2008, the policy of “aggressive diplomacy” was put in motion. While pretending to engage Iran in diplomacy, the Obama Administration, in coordination with the US Congress and the government of Israel, pushed for the most confrontational IAEA reports on Iran and an unprecedented set of unilateral and multilateral sanctions. The US and Israel also engaged in a campaign of military threats, sabotage and assassination of Iranian nuclear scientists. Yet, after four years of hostilities, the policy of “tough diplomacy” failed to achieve many of its goals and failed to contain Iran.
