KEY ELEMENTS OF CONJUNCTURAL ANALYSIS

SEVERAL KEY ELEMENTS CHARACTERIZE A STRONG CONJUNCTURAL ANALYSIS:

CONTEXTUALIZATION: THIS IS THE CORNERSTONE OF CONJUNCTURAL ANALYSIS. IT AVOIDS DETERMINISTIC EXPLANATIONS, RECOGNIZING THE ROLE OF CHANCE AND UNFORESEEN CIRCUMSTANCES.

MULTI-PERSPECTIVITY: A ROBUST CONJUNCTURAL ANALYSIS CONSIDERS MULTIPLE PERSPECTIVES AND AVOIDS IMPOSING A SINGLE, OVERARCHING NARRATIVE. IT ACKNOWLEDGES THE DIVERSITY OF EXPERIENCES AND INTERPRETATIONS SURROUNDING AN EVENT OR PHENOMENON.
