Billy starred in a Hollywood movie, *The Pittsburgh Kid*, and developed friendships with big stars like Bob Hope, Robert Taylor, and Frank Sinatra. Through all the glamour Billy remained the unpretentious kid from gritty Pittsburgh, the city he loved. He became an icon of that city, of the downtrodden Depression-era working class, and of the American Irish.
