THE CPT CODE FOR ANNUAL WELLNESS VISITS: 99490

THE PRIMARY CPT CODE USED FOR AN ANNUAL WELLNESS VISIT IS 99490. THIS CODE SPECIFICALLY COVERS A COMPREHENSIVE, PREVENTIVE MEDICINE VISIT FOR INDIVIDUALS GENERALLY CONSIDERED TO BE HEALTHY. THIS VISIT IS DISTINCT FROM OTHER TYPES OF OFFICE VISITS AND FOCUSES ON PREVENTATIVE CARE, WELLNESS PROMOTION, AND RISK FACTOR REDUCTION. IT'S NOT MEANT FOR TREATING ACUTE ILLNESSES OR INJURIES, THOSE REQUIRE SEPARATE CODES. THIS IS CRUCIAL; MISUSING THIS CODE CAN LEAD TO BILLING DENIALS.

WHAT 99490 INCLUDES:

PERSONAL AND FAMILY HEALTH HISTORY REVIEW: THIS INVOLVES A DETAILED DISCUSSION WITH THE PATIENT ABOUT THEIR MEDICAL HISTORY, INCLUDING FAMILY HISTORY OF DISEASES, LIFESTYLE FACTORS, AND ANY CONCERNS THEY MAY HAVE.

RISK ASSESSMENT: THIS IDENTIFIES POTENTIAL HEALTH RISKS BASED ON THE PATIENT'S HISTORY, AGE, LIFESTYLE, AND OTHER RELEVANT FACTORS. THIS COULD INCLUDE SCREENINGS FOR HYPERTENSION, CHOLESTEROL, DIABETES, AND CANCER.

PREVENTIVE COUNSELING AND EDUCATION: THIS IS A SIGNIFICANT ASPECT OF 99490. IT COVERS EDUCATION ON HEALTH PROMOTION, DISEASE PREVENTION, AND RISK REDUCTION STRATEGIES TAILORED TO THE INDIVIDUAL PATIENT.
