ANSWER KEY" MIGHT PRESENT A MONOLITHIC VIEW OF THE FOUNDING FATHERS' INTENTIONS, NEGLECTING THE DIVERSE PERSPECTIVES AND EVOLVING INTERPRETATIONS THAT HAVE SHAPED CONSTITUTIONAL LAW OVER CENTURIES. THE RISK IS CREATING A STATIC, RATHER THAN DYNAMIC, UNDERSTANDING OF A LIVING DOCUMENT.
