And Elvis was trapped playing years of arduous seasons in Las Vegas - two shows nightly, seven days a week, until boredom and despair brought on the excessive drug use that killed him - because for Parker he was an open chit - whose huge earnings prevented his manager's losses at the gambling tables being called in. Alanna Nash knew Parker towards the end of his life, and has now uncovered the whole story, improbable, shocking, and never less than compelling, of how this larger-than-life man made, and then unmade, popular music's first and greatest superstar.
