1. MY DAUGHTER IS UNHAPPY WITH HER HUSBAND'S INFLUENCE ON THE FAMILY. WHAT SHOULD I DO? SUPPORT YOUR DAUGHTER AND ENCOURAGE HER TO COMMUNICATE HER CONCERNS DIRECTLY WITH HER HUSBAND. MEDIATION OR FAMILY THERAPY MIGHT BE BENEFICIAL IN HELPING THEM WORK THROUGH THEIR DIFFERENCES.
1. HOW CAN I ENSURE FAIR DECISION-MAKING WHEN MY SON-IN-LAW HAS A STRONG FINANCIAL CONTRIBUTION TO THE FAMILY? TRANSPARENCY IS KEY. ENSURE ALL FINANCIAL CONTRIBUTIONS AND DECISIONS ARE DISCUSSED OPENLY AND INVOLVE ALL RELEVANT FAMILY MEMBERS.
