HE DEMONSTRATED THAT A MARXIST FRAMEWORK, WHEN USED CRITICALLY AND JUDICIOUSLY, CAN PROVIDE VALUABLE INSIGHTS INTO THE SOCIAL AND POLITICAL DIMENSIONS OF LITERATURE, EVEN IF ONE ULTIMATELY REJECTS THE BROADER TENETS OF MARXIST IDEOLOGY.

1. THE ENDURING INFLUENCE: WILSON'S CRITICAL LEGACY
