THE ABILITY TO IDENTIFY AND TRACK INDIVIDUALS EFFORTLESSLY PROVIDES A POWERFUL TOOL FOR STATE SURVEILLANCE AND REPRESSION.

SECURITY RISKS: WHILE TOUTED AS A SECURITY MEASURE, FACIAL RECOGNITION SYSTEMS ARE THEMSELVES VULNERABLE TO HACKING AND MANIPULATION. DATA BREACHES COULD EXPOSE SENSITIVE PERSONAL INFORMATION, LEADING TO IDENTITY THEFT AND OTHER SERIOUS CRIMES. THE PROPOSED (OR ENACTED) FACIAL RECOGNITION AND BIOMETRIC TECHNOLOGY MORATORIUM ACT: KEY PROVISIONS
