UPDATES AND SUPPORT: THE FIELD OF COMPUTER FORENSICS IS CONSTANTLY CHANGING. CHECK IF THE DVD PROVIDER OFFERS UPDATES OR SUPPLEMENTARY MATERIALS TO KEEP THE CONTENT CURRENT. CONSIDER WHETHER ANY SUPPORT IS PROVIDED, SUCH AS FORUMS OR Q&A SESSIONS.

ESSENTIAL TOPICS COVERED IN A COMPREHENSIVE COMPUTER FORENSICS DVD

A THOROUGH COMPUTER FORENSICS AND INVESTIGATIONS DVD SHOULD COVER THESE KEY AREAS:

LEGAL AND ETHICAL CONSIDERATIONS: UNDERSTANDING THE LEGAL AND ETHICAL IMPLICATIONS OF COMPUTER FORENSICS IS ESSENTIAL. THE DVD SHOULD DISCUSS RELEVANT LAWS, REGULATIONS, AND ETHICAL GUIDELINES.

BEYOND THE BASICS: ADVANCED TOPICS COVERED BY HIGHER-LEVEL DVDS

1. WHAT SOFTWARE IS TYPICALLY USED IN COMPUTER FORENSICS AND SHOULD I EXPECT IT TO BE INCLUDED IN THE DVD? POPULAR FORENSIC SOFTWARE INCLUDES AUTOPSY, ENCASE, FTK, AND X-WAYS FORENSICS. SOFTWARE IS NOT ALWAYS INCLUDED WITH A DVD, AND YOU MIGHT NEED TO PURCHASE IT SEPARATELY. SOME DVDS MAY OFFER TRIAL VERSIONS OR LINKS TO FREE SOFTWARE.
