STARTING A PRESCHOOL REQUIRES SIGNIFICANT UPFRONT INVESTMENT. EXPLORE VARIOUS FUNDING OPTIONS:

PERSONAL SAVINGS: THIS IS OFTEN THE FIRST STEP, PROVIDING THE INITIAL CAPITAL FOR SETUP.

SMALL BUSINESS LOANS: BANKS AND CREDIT UNIONS OFFER LOANS SPECIFICALLY DESIGNED FOR SMALL BUSINESSES. BE PREPARED TO PRESENT A STRONG BUSINESS PLAN.

7. ONGOING OPERATIONS AND GROWTH: SUSTAINING SUCCESS

PARENT COMMUNICATION: MAINTAIN OPEN COMMUNICATION WITH PARENTS THROUGH REGULAR UPDATES, NEWSLETTERS, AND PARENT-TEACHER CONFERENCES.
