HE CONTRASTS THIS WITH PROTECTIONIST ENVIRONMENTS THAT STIFLE COMPETITION AND DISCOURAGE INNOVATION, LEADING TO TECHNOLOGICAL BACKWARDNESS AND ECONOMIC STAGNATION.
1. **THE IMPORTANCE OF INTERNATIONAL COOPERATION:** BHAGWATI IS A STRONG PROPONENT OF INTERNATIONAL COOPERATION AS A CRUCIAL ELEMENT IN MANAGING GLOBALIZATION'S CHALLENGES.
